Dear Friends,

The Riley County Fair Board is extending an invitation for your group to participate in the 2018 Fair Parade, Thursday, July 26 at 6:00 p.m. The parade will proceed out of the Manhattan Town Center going west on Poyntz Ave and ending at the city park. On the back of this letter is a map showing where to check in and the parade route.

Parade participants should arrive in the staging area at the NE corner of Dillard's parking lot at the Manhattan Town Center Mall. Please arrive Thursday, July 26 between 5:30 and 5:45 pm. This year's Riley County Fair theme is *Blue Jeans & Country Dreams*. This may be helpful as you design your parade entry.

Parade marshals (in an orange vest) will be on hand to assist in lining up parade entries. The marshals will be located in the NE corner of Dillard's parking lot of the Manhattan Town Center to direct the parade line up. **No pre-entry** is required for your organization to participate, just show up before parade time. There will be no set order for parade entries. Once you have checked in you will be directed to park entries in staging area. Parade marshals will direct you to pull into the line to begin the parade. Parking of extra vehicles will not be allowed in the staging area, however, the north lot of Dillard's can be used. We look forward to your participation in the 2018 Riley County Fair Parade.

***Notice: Due to a city ordinance, candy or other objects cannot be thrown from moving vehicles or parade floats. Objects can be handed out if desired.***

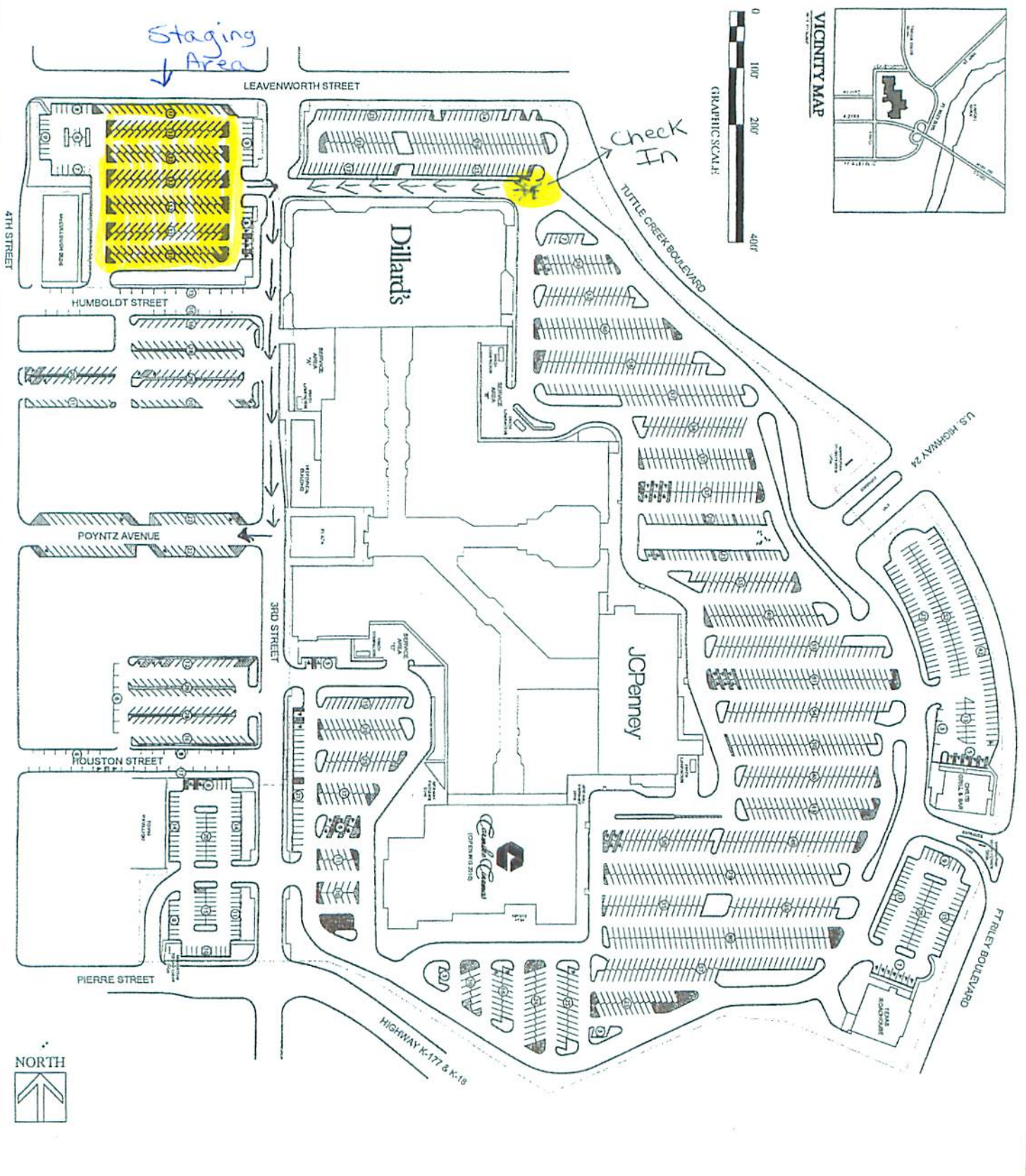
